Non-Malaysians with a valid passport, residential address in Malaysia, and hold a Malaysia bank account are allowed to participate.

Category A: My Family, My Malaysia
Create a doodle that shows how your family celebrates, explores or enjoys life in Malaysia. Let your imagination run wild by adding colours, patterns, favourite places, food, nature, traditions or anything that makes your family uniquely Malaysian.

Category B: Our Future Malaysia
Illustrate your vision of Malaysia's future through creative doodles. You may include ideas about technology, sustainability, environmental conservation, education, smart cities, cultural harmony, community, or any positive changes that inspire hope for our nation.

Category C: Every Contingent Counts
Express your interpretation of unity through doodles that celebrate the diverse people, cultures, communities and everyday moments that connect Malaysians. Show how different stories, perspectives and experiences come together to create one united Malaysia.
 - Submission of artwork can be done any time through MyTOWN website once completed before 6 Sept 2026. Late submissions will not be accepted.
- Entries will be judged equally based on:
 - Creativity & Originality : 30%
 - Theme inspiration : 30%
 - Visual Storytelling : 20%
 - Composition : 10%
 - Technical execution : 10%
- Judges' decision is final, conclusive and binding. No further appeal, enquiry and/or correspondence will be entertained.

Judging Criteria

1. Participants will be judged based on the criteria listed below.

 - Theme inspiration : 30%
 - Visual Storytelling : 20%
 - Composition : 10%
 - Technical execution : 10%
